#### 1. INTRODUCTION

The purpose of this circular is to provide you with information relating to the Ordinary Resolutions to be proposed at the Annual General Meeting involving but not limited to (a) re-election of retiring Directors; and (b) the Buy-back Mandate and the Share Issue Mandate.

#### 2. RE-ELECTION OF RETIRING DIRECTORS

The Board currently consists of six members, including the following Directors:

In accordance with Article 105(A) of the Articles, Mr. Chan Mei Ying Spencer ("Mr. Chan") and Ms. Tsang Wai Chun Marianna ("Ms. Tsang") shall retire by rotation and be eligible for re-election at the Annual General Meeting. Mr. Chan and Ms. Tsang have offered themselves for re-election at the Annual General Meeting.

Ms. Tsang and Mr. Chan were appointed on 16 October 2003 and 25 October 2005 respectively and have served the Company as independent non-executive Directors for more than nine years as at the Latest Practicable Date.

Code provision A.4.3 of Appendix 15 Corporate Governance Code and Corporate Governance Report of the GEM Listing Rules recommends that serving more than nine years could be relevant to the determination of a non-executive Director's independence and that any further appointment of such independent non-executive Director should be subject to a separate resolution to be approved by Shareholders.

Notwithstanding that Ms. Tsang and Mr. Chan have served as independent non-executive Directors for more than nine years, (i) the Board has assessed and reviewed the annual confirmation of independence based on the criteria set out in Rule 5.09 of the GEM Listing Rules and affirmed that Ms. Tsang and Mr. Chan remain independent; (ii) the Nomination Committee of the Company (excluding Ms. Tsang and Mr. Chan who have abstained from voting) has assessed and is satisfied with the independence of Ms. Tsang and Mr. Chan; and (iii) the Board considers that Ms. Tsang and Mr. Chan remain independent of management of the Group and free of any relationship which could materially interfere with the exercise of their independent judgement. # 5. DIRECTORS, THEIR CLOSE ASSOCIATES AND CORE CONNECTED PERSONS

None of the Directors nor, to the best of their knowledge and belief having made all reasonable enquiries, any of their close associates (as defined under the GEM Listing Rules) has any present intention, in the event that the Buy-back Mandate is granted by Shareholders, to sell Shares to the Company.

No core connected person of the Company as defined in the GEM Listing Rules has notified the Company that he/she has a present intention to sell any Shares to the Company nor has he/she undertaken not to sell any of the Shares held by him/her to the Company in the event that the Company is authorised to make buy-backs of Shares.

#### 6. EFFECT OF TAKEOVERS CODE

The Directors are not aware of any consequences which will arise under the Takeovers Code as a result of any buy-back made under the Buy-back Mandate.

In the event that the Directors exercise in full the power to buy back Shares which is proposed to be granted pursuant to the Ordinary Resolution numbered (5)(i), then (based on the present shareholdings as at the Latest Practicable Date) the shareholding of Mr. Felipe Tan <sup>(note)</sup> would be increased from approximately 29.73% to approximately 33.03%. In the opinion of the Directors, such increase would give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code. However, the Directors have no present intention to exercise the buy-back of Shares to an extent that would result in such takeover obligations.

Note: Mr. Felipe Tan has an interest in 836,202,400 Shares, representing approximately 29.73% of the issued Shares of the Company. The interest includes: (i) 158,128,000 Shares directly held by Mr. Felipe Tan; and (ii) 678,074,400 Shares held by Starmax Holdings Limited, a company which is beneficially owned as to 100% by Mr. Felipe Tan. By virtue of the Securities and Futures Ordinance, Mr. Felipe Tan is therefore deemed to have an interest in the Shares in which Starmax Holdings Limited is interested.

Mr. Chan has a Computer Science degree from the University of Melbourne, Australia, followed by a Master's Degree in Business Administration from the Chinese University of Hong Kong. He also has attended an executive management program at INSEAD, Fontainbleau, France. The appointment of Mr. Chan as an independent non-executive Director of the Company is of a term of one year and renewable annually. For the year ended 31 March 2019, Mr. Chan's total emolument, comprising director's fee, was approximately HK\$126,000. The emoluments of the directors of the Company are decided by the remuneration committee, having regard to the Company's operating results and comparable market statistics. Mr. Chan did not hold any directorship in other listed companies in the last three years.

As at the Latest Practicable Date, Mr. Chan is interested in 1,800,000 Shares, and in 1,000,000 share options and underlying Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance. Mr. Chan is not related to any Directors, senior management, Substantial Shareholders, or controlling Shareholders of the Company.

Save as disclosed above, Mr. Chan has no information to be disclosed pursuant to any of the requirements of Rule 17.50(2) of the GEM Listing Rules (particularly in relation to sub-paragraphs (h) to (v) therein) nor are there other matters that need to be brought to the attention of the Shareholders.

Ms. TSANG Wai Chun Marianna, aged 64, has been appointed as an independent non-executive Director since 16 October 2003. She is the Managing Director of TWC Management Limited. She is a Chartered Secretary, a Chartered Governance Professional and an Associate of both the Institute of Chartered Secretaries and Administrators in UK and the Hong Kong Institute of Chartered Secretaries. She is also a member of the Taxation Institute of Hong Kong, the Society of Registered Financial Planners, the Chartered Institute of Arbitrators, the Institute of Financial Accountants and the Institute of Public Accountants in Australia and the Association of International Accountants in UK. She obtained a postgraduate certificate in Professional Accounting. Ms. Tsang had been a member of the Board of Review (Inland Revenue Ordinance) from 2010 to 2015. She has over 30 years working experience covering the spectrum of accounting, company secretarial, corporate affairs, and related legal working experience in major commercial corporations and in professional firms. Ms. Tsang has served as an independent non-executive director of Loco Hong Kong Holdings Limited, the shares of which are listed on GEM (stock code: 8162), since 22 July 2014. The appointment of Ms. Tsang as an independent non-executive Director of the Company is of a term of one year and renewable annually. # NOMINATION POLICY AND RE-ELECTION OF INDEPENDENT NON-EXECUTIVE DIRECTORS

The Nomination Committee and the Board have followed the nomination policy and board diversity policy of the Company for the re-appointment of Mr. Chan and Ms. Tsang as independent non-executive Directors. In reviewing the structure of the Board, the Nomination Committee and the Board will consider the Board diversity from several aspects, including but not limited to gender, age, culture and education background, professional experience, skills, knowledge and length of service. With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. All Board appointments will be based on meritocracy, and candidates will be considered against appropriate criteria, having due regard for the benefits of diversity on the Board.

The Nomination Committee, after having reviewed the profile of the retiring Directors who have offered themselves for re-appointment at the Annual General Meeting to consider their suitability in light of the structure, size and composition of the Board, nominated Mr. Chan and Ms. Tsang to the Board for it to recommend to Shareholders for re-election as Directors at the Annual General Meeting. Mr. Chan and Ms. Tsang who are members and present at the meeting of the Nomination Committee, abstained from voting at the meeting of the Nomination Committee when their respective nominations were being considered. The Board accepted the nomination by the Nomination Committee and recommended Mr. Chan and Ms. Tsang to stand for election by the Shareholders at the Annual General Meeting.

In recommending each of Mr. Chan and Ms. Tsang to stand for re-election as an independent non-executive Director, the Nomination Committee has considered backgrounds and attributes of each of Mr. Chan and Ms. Tsang as mentioned in their particulars above.

# PARTICULARS OF RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED

The Nomination Committee considered that in view of their diverse and different educational backgrounds and professional knowledge and experience in the respective fields of corporate finance, business development, sales and marketing, accounting, company secretarial, corporate affairs, and related legal working experience as mentioned above, Mr. Chan and Ms. Tsang as independent non-executive Directors will bring valuable perspectives, knowledge, skills and experiences to the Board for its efficient and effective functioning and their appointments will contribute to the diversity (particularly in terms of skills) of the Board appropriate to the requirements of the Company's business.

The Nomination Committee also assessed and reviewed the annual confirmation of independence based on the independence criteria as set out in Rule 5.09 of the GEM Listing Rules of each of Mr. Chan and Ms. Tsang and re-affirmed their independence.
